- 1. All seasonal use permits for use of Gana-A'Yoo lands are subject to the final approval of the Gana-A'Yoo board of directors.
- 2. This permit is not a hunting or fishing license.
- 3. The building of permanent structures is prohibited.
- 4. All land areas utilized will be maintained in a neat and orderly condition and all trash will be removed upon conclusion of use.
- 5. Permits may be authorized to government agencies, e.g., US Fish and Wildlife Service on a case-by-case basis with approval by the Gana-A'Yoo board of directors.
- 6. Fees may be waived at the discretion of the board of the Gana-A'Yoo board of directors.

Agreed Terms and Conditions: Applicant acknowledges that he/she has read the rules and restrictions and agrees to comply with them as a condition of the grant of permit and use. Applicant agrees to the fullest extent permitted by law to release, defend, indemnify and hold harmless Gana-A'Yoo, Limited and its officers, directors, employees, agents, contractors, subsidiaries, affiliates, successors and assigns, from and against all claims, attorneys' and experts' fees (including all actual costs incurred in defense or as a result of such claims), damages, losses, or injuries (including death) of any kind whatsoever arising or alleged to arise while or because of applicants being on, use of, or travel to or from Gana-A'Yoo, Limited lands or arising or alleged to arise out of this application or permit. This release applies to any and all claims arising out of the alleged negligence of any of the releases.
