







# Original LEADERSHIP

Over 50 years ago, the United States Congress passed the Alaska Native Claims Settlement Act (ANCSA), which created what are today's Alaska Native regional and village corporations. Seven years later, in May 1978, Gana-A'Yoo, Limited was established when the village corporations Notaaghleedin, Limited; Mineelghadza'Toh, Limited; Nik'aghun, Limited and Takathlee-tondin, Incorporated merged, creating our Denaakk'e name meaning "friends together."

For this issue, we interviewed one of Gana-A'Yoo's original leaders, Miranda Wright. Wright is the daughter of the late Eddie and Alice Hildebrand of Nulato. Her maternal grandmother was known as Little Lisa, or Adinonaadlino, who was of the Kaiyuh people and the Toneedze Gheltseelne clan. Her maternal grandfather was Clark Carey, an Irishman who arrived in Nulato with the Signal Corp. Wright's paternal grandparents are the late Peter Esmailka and Martha Esmailka-Joe. Wright was born in her family's winter camp on the Mud River, where she lived until she moved to Nulato

at age 6, when the Alaska territorial government mandated all children attend school. Were you involved in the formulation of ANCSA? If so, how did you become involved? How did your journey start?

Few women were actively involved in the formulation of ANCSA. It was a different space and time, so most women advocated in the background. Many held bake sales as fundraisers for the ANCSA movement. As for myself, I hosted private dinner meetings for several Native leaders as they engaged with my brothers-in-law, Jules and Don Wright, who were active in the ANCSA movement. Prior to this, I was a student at the University of Alaska Fairbanks along with Willie Hensley, John Sackett, Reva Wulf and a handful of other Alaska Native students. We were all aware of the pressing issues our people were facing after Alaska was granted statehood. It was during this period that Willie wrote his now-famous paper on who owns Alaska. You might say that I was in the eye of the storm from the beginning; however, due to societal restrictions, women often worked in the background, providing support to the effort in subtle ways.

What was your involvement with the creation of the Nulato/Kaltag/Galena/Koyukuk village corporation? I was not involved in the creation of Nik'aghun, Limited. I ran for election once I saw how unstable the corporation was. The corporate concept was foreign to many of our people. They were trying to hold things together, but it was a real challenge dealing with all the federal and state requirements while understanding the financial aspect of running a for-profit company with shareholders that demand accountability.

#### What was your involvement with Gana-A'Yoo's 1977-1978 merger of the village corporations?

It was during my tenure on the Nik'aghun, Limited Board of Directors that the discussion surfaced to merge our sister villages into one corporation. Much like Nik'aghun, other village corporations were struggling with this new concept called corporations. A couple villages had populations of less than 100 residents. Often our seasonal harvests put added pressure on the corporate office as people were actively working to keep food on their tables. After many meetings, it was decided that unity and support was necessary to keep our land intact and under Native ownership. By merging, we could share expertise, cut administrative costs and pool our financial resources to help grow the company.

#### What were the early days of corporate life like? How did you learn to navigate corporate life?

For the village corporations, those early days were hectic, scary, confusing and required a lot of work educating our people on how to navigate a foreign system. When I ran for election to our village corporation Board of Directors, I had already been in business for a number of years. I had established a corporation for the construction company my husband and I ran, so I had a good understanding of how a corporation works.

#### Did you sit on the Board of Directors for Gana-A'Yoo? If so, did you hold any positions on the board?

If my memory serves me, I stayed on for one term after Gana-A'Yoo was established. I felt my goal to stabilize my village corporation had been accomplished. In the process, our sister village corporations were also in recovery mode. All were benefiting from the merger.

#### What were your hopes and aspirations for the corporation?

The objective from the start was to make money. The focus was very conservative and to proceed with a vision. In those early days, much of our money was in the stock market.

#### How did Gana-A'Yoo hold up to your expectations in today's day and age?

I am extremely proud of Gana-A'Yoo and the growth trajectory they are on. They have a strong board and a great management team.

#### How do you envision Gana-A'Yoo in the future?

Maintain the focus on educational and career opportunities for shareholders as the company continues to grow and expand shareholder equity.

# SUBSIDIARY Spotlight

Kaiyuh Services was awarded a four-year sole source contract to oversee and operate the Yuma Desalting Plant on behalf of the U.S. Bureau of Reclamation under the U.S. Department of Interior. This plant encompasses 60 acres, or 2.6 million square feet, of space that is comprised of both a research testing facility and real-time desalination plant capable of producing over 96 million gallons of desalted water per day. The plant has 43 full-time staff on hand to keep it in "ready mode" in case the plant must be turned on due to a water shortage, or if the salt content in the Colorado River exceeds standard levels caused by leaching from the surrounding area farmlands.

# Teacher HOUSING

Over the last several months, Gana-A'Yoo has been working closely with the Galena City School District to provide more teacher housing options. Since 2015, the school district has leased Gana-A'Yoo's seven-plex for teacher and school administrator housing, and recently added an additional building to their lease agreements. The school district applied for the Alaska Housing Finance Corporation's Professional Housing Grant to renovate and refurbish the seven-plex beginning next year to ensure the property remains adequate for housing. The school district has expressed their gratitude to Gana-A'Yoo, and we look forward to building stronger relationships that contribute to building a better tomorrow for our youth of today.

"The Galena City School District is grateful for our ongoing collaboration and partnership with Gana-A'Yoo in a joint effort to best serve the children and students of our region. This strong relationship has recently resulted in a 28 percent increase in available teacher housing units and potentially a dramatic remodel of these facilities here in Galena, and has substantially elevated our capacity to meet the needs of our professional educators and to ensure that we are in a position to provide our students with an impactful education that they deserve."

Congratulations to long-standing employee, Janelle Huntington, recipient of Gana-A'Yoo, Limited's first Employee of the Year award! This new annual award recognizes an employee whose loyalty and consistent efforts embody and are reflective of Gana-A'Yoo's mission, vision and values. The selected employee consistently demonstrates these principles, and their actions add to the improvement, quality and performance of our corporation through their professionalism, customer focus, quality, teamwork and innovation.

Huntington has been an exceptional asset to Gana-A'Yoo, Limited since June 2013. Huntington was a student at the University of Alaska Anchorage (UAA) when she began her career at her village corporation as a temporary office clerk, assisting in various departments. Eventually, she transitioned to the Human Resources (HR) Department as a regular, part-time HR clerk in 2014. The next year, she moved into an HR assistant position and transitioned to a full-time employee in 2016. Huntington graduated from the Doyon Leadership Training and from UAA with her Bachelor of Science in aviation management with a minor in Alaska Native studies and business administration in 2017. After graduating, she made the tough decision to take an internship at an airline as a systems safety analyst. She explained, "I loved working for Gana-A'Yoo, but I wanted to utilize my degree and discover my career path. When I resigned, I decided I wanted to still be involved with the company, so I ran for the Gana-A'Yoo Foundation Board of Directors, which allowed me to give back to the Foundation that had so graciously supported me with my educational endeavors." Huntington served as a Foundation board member for a term from August 2017 until 2020.

While Huntington enjoyed working in her field of study in the aviation industry, she found herself missing the culture, values, people and environment of the Alaska Native corporation she had become so fond of. Once Huntington completed her three-month internship, she was offered a full-time position. Simultaneously, Gana-A'Yoo took the opportunity to encourage her to apply for a vacant HR generalist position. "I knew it was the right decision to come back to Gana-A'Yoo. I love working here because it brings me closer to my culture, and, in my role, I help people, which is my passion," she said. Huntington was promoted to senior HR generalist in 2020 and received her Professional in Human Resources certification in 2021.

Huntington is the daughter of Harold and Shirley Huntington, and the granddaughter of the late Jennie Huntington of Koyukuk.
