### **IMPORTANT**

- You must pass the facility vetting successfully to enter the base. All drivers will be vetted at the gate; this can take up-to 2 hours depending on the base access line, plan accordingly. Security will be conducting a background check on the spot for all drivers, if you do not pass the background check, you will not be allowed on the base.
- All vehicles entering or exiting are subject to inspections. If an individual refuses to submit to an inspection upon entry, the individual will not be allowed access. If an individual refuses to submit to an inspection upon departing, he or she will be detained and appropriate action taken.
- Upon arrival to the base, you **MUST** have a photo ID and, if driving, proof of auto insurance.
- Installations can require every person in the vehicle to present an ID; if your ID is not up-to-date, you will
  not be able to gain base access. All visitors over the age of eighteen must be in possession of a valid
  form of government-issues photo identification
- You **MUST** drive through the gate to the auction area only.
- The privilege to access the installation may be revoked by the Commanding Officer at any time.
- Escorts to or from the auction site will not be arranged or authorized, no exceptions.
- Photography is strictly prohibited.
